#### 6. Highways

**6.1** Parish Boundary Signs – Councillor Charlesworth has been engaging with Cheshire East over the process and it was resolved **(0723/05)** to submit a formal request to replace seven existing parish boundary signs with a new design and put down the £1000 deposit as requested.

**6.2** Community Speed Watch – it was noted that Councillor Andrews has been informed by PCSO Kim Bowyers that this scheme is currently on hold.

## 7. Planning Applications/Decision/Inquiry.

7.1 23/2403c Maple Close CW11 1SG - it was resolved (0723/06) to support the application.

**7.2** 23/1928w Somerford Farm CW12 4SN - it was resolved (0723/07) to object to the application on the grounds that in the main, the application is contrary to the Brereton Neighbourhood Plan as it fails to meet the requirements of BNP policy ENV03 Nature Conservation. It also fails to demonstrate independent monitoring of air quality allaying the potential risk of air particles to the local community.

**7.3** 23/2488c 35 St Oswald's Crescent CW11 1RW - it was resolved **(0723/08)** to make a general observation on the application that the height of the proposed fence hinders visibility and is not in keeping with the area.

7.4 232761c Woodside Moss Lane CW12 4SX – it was resolved (0723/09) to support the application.

7.5 23/2496c Long Lane Farm CW11 2SR – it was resolved (0723/10) to support the application.
