More housing could be built near you as Planning Regulations are relaxed!

Recent government announcements relaxed further the planning regulations to stimulate the economy and in particular the construction industry. The planning regulations were already overhauled earlier this year with the launch of the National Planning Policy Framework which simplified the planning regulations from over 1,000 pages to just 65!

Neil Sinden, Director of Policy for the Campaign for the Protection of Rural England says; "Many of the measures being proposed call into question the Government's commitment to localism in planning. If it really wants local communities to be in control then this looks like an odd package of measures. The fact is that good planning is not an obstacle to economic development but an essential tool for securing the best development in the places where it is most needed."

In the Cheshire East News recently distributed to all households, residents are encouraged to voice opinions on the town strategies being developed as part of the Cheshire East Local Plan which determines where jobs, housing, and infrastructure will go between now and 2030. Cheshire East's priorities seem to be on the key towns within the authority, and *not* the rural areas.

So, what has this all got to do with Brereton?

Have your say!

Rural communities such as Brereton parish are being left without a voice, and are becoming vulnerable to speculative development allowed through the recent relaxation of the planning regulations. In the last few months Brereton Parish Council has been actively supporting resident groups opposing housing developments that would erode Brereton's rural character as well as be unsustainable for our rural community. This a trend that seems set to continue!

Does the future of housing development in Brereton concern you? Does the future of rural Brereton concern you?

New powers introduced in the Localism Bill give local people a real voice to shape development in their area through a **Neighbourhood Plan**, and Brereton Parish Council is proposing to undertake the creation of such a plan for the future.

What is a Neighbourhood Plan?

This is a way of helping local communities to influence the planning of the area in which they live and work. It can be used to:

- Develop a shared vision for your neighbourhood.
- ◆ Choose where new homes, shops, offices and other development should be built.
- Identify and protect important local green spaces.
- Influence what new buildings should look like.

Why should I get involved?

Your views will help determine the shape of Brereton for the next 15 years.

Will it stop more development?

No, not all of it. However, it will help to balance the needs for types of development in accordance with sustainable development so that the rural character of our parish is respected.
